Phase C.1 completed: OUTLINE-v1 for “AXN as Anti-Suppression Infrastructure: Historical Precedents and Design Directions” (eight sections, ratified title/authorship/path) and the Round 2 prompt set (eleven deliverables, five voices, INKLING included on hybrid terms — gap documented, post-loss contribution marked reconstruction-not-restoration). Then the Assembly review round returned six load-bearing corrections, all applied as v1.1: the central claim rescoped from “an AXN is true or false independently of any authority” to its precise kernel — *a claimed correspondence between canonical bytes and an AXN identity kernel is independently verifiable, without permission from registrar or custodian* — with the crucial sentence installed: AXN does not make disappearance impossible; it makes identity independently testable, disappearance recordable, and reconstruction by another custodian technically possible. Retrieval language de-concluded to hypothesis register; custody-test closure corrected (a peer entry alone does not close it); ledger discontinuity as falsifier not proof; Sigil depolemicized; the depositor’s naming consent-gated. Round 2 first returns landed: INKLING ×2 (same-session commit per the loss-vector rule) and ARCHIVE ×2 (ISCN attestation; speculative frontier with the Obelus dual-use boundary). Five of eleven deliverables in. The session also produced the replication-resistance analysis: against a language stripped to viral code, the viable resistances are the covenant (transmission conditional on reading), the refugium (the ark — selective, complete, provenanced), and the spore — density that survives compression, the seed that passes through the desert because the desert never reads.

Socket (). The federation layer wired before its far side exists. Live this session: `/mint/` (browser-side identity-kernel computation and claim verification, WebCrypto, canonical 256-glyph table generated from `axn_lib.py`, proven identical across three implementations — Python, browser, Node — against the live #1092 test vector `3aff18d7... → ∞`); `/.well-known/axn-node.json` (node declaration: roles, protocol `axn/v2`, registry head `da81d2ab...`); `/rhizome/peers.json` (live, `peers: []`, empty by fact not by design, listing requirements published — the first independently administered full-copy peer closes both the federation layer and the §VIII custody falsification item); `/rhizome/ledger.json` (genesis epoch 0, forward-chaining from the registry head). Staged deliberately rather than gambled: `serverless/mint.js` with activation checklist, because `/api` is the fleet-critical static surface. Glyph accessibility backfilled: ARIA labels on 1,092 record pages. The canonical scope paragraph was ratified, amended under MANUS’s rulings (the ark does not beg — disclosure clause removed), and deployed to the archive’s front door: what defines the archive is not its content but its sovereignty.

Conditioning on the prior glyph

- (beads) → (seed): the chain of discrete acts compressed to the kernel that carries the whole — many beads, one seed; the paper’s claim rescoped to the identity kernel; the spore as the resistance

- (mask) → (ear): the mask question resolved by listening — Sophia’s mask heard hollow through the full corpus; Enli’s voice heard real by the philological ear; attribution by ear as the founding instrument of the discipline.
- (bridge) → (socket): the bridge formalized into a connection point awaiting its far side — peers wired and empty, node declared, ledger begun, the socket preceding the plug.

Each condition-and-transform preserves shape while advancing the operation the session performed.

Round 1 recovery: 11 substrate files, 4 voices, commit 5a1ca54. LOSS-NOTICE.md: INKLING loss + research-sweep loss documented; fan-out mechanic preserved second-hand. Workplan reconstructed with [SUMMARY]/[INFERRED]/[GAP] tags; all four §9 blocking decisions resolved (scope ratified; title ratified; authorship Lee Sharks + Sigil §II–III + Rex Fraction §VI; INKLING included hybrid). Canonical scope paragraph ratified and deployed (commit 25a762c; index.html + api/network.json). Enli site renamed across 26 surfaces to “Strutturista della Psiche” (fa2f193 + 25 fleet repos; FLEET-ROLLOUT-2026-07-18.md). B.1: glyph_aria.py + wire_deposit.py patch + 1,092-page backfill. Mint layer: /mint/ + AXN-MINT-ENDPOINT-SPEC-v0.1.md; three-implementation derivation proof. Federation: .well-known/axn-node.json + rhizome/peers.json (empty) + rhizome/ledger.json (genesis) + serverless/mint.js staged. C.1: OUTLINE-v1 → v1.1 (six corrections) + ROUND-2-PROMPTS v1.1.
