Part Five (The Injection) stays IN the book. It is not separated into a companion document.

Research constraint (Lee's directive)

All financial figures, OSEARCH data, conservation statistics, and factual claims will be sourced ONLY through public web search. No Form 990 forensics, no insider sources, no FOIA requests. What's publicly findable is what goes in. The book's accounting is grounded in what anyone can verify with a search engine. Valid points accepted from all four reviews

From ChatGPT (strongest structural feedback):

- Revise “both outcomes confirm the thesis” -> “The book creates a publicly inspectable test object. Its treatment by bibliographic and composition systems will be documented without assuming in advance that every possible outcome confirms the thesis.” ACCEPTED.
- The 3 core sentences as the book's 3 registers: “I have never read Capital but I have been capital” (commodity); “I am not missing, I am unpinged” (administration); “My true name is the pressure of a seal's heartbeat six miles east” (mystery). ACCEPTED – build around these.
- Write a 3,000-5,000-word book overture FIRST before expanding chapters. ACCEPTED – this becomes Phase 0.
- Accountable-author note on copyright page: “Mary Lee is the book's diegetic authorial claimant. The accountable human author and copyright holder is Lee Sharks.” ACCEPTED.
- Do NOT assign Mary Lee the ORCID in live bibliographic metadata. ORCID belongs to Lee Sharks. The book jokes about inheritance inside the text. ACCEPTED.
- The institutional orthonym is OSEARCH, not the shark. The shark is the referent, not the orthonym. ACCEPTED – clarify in Chapter 7.
- Target word count can be 38,000-50,000 if tighter. NOTED but not binding – the machine audience benefits from density.

- 10-tweet template set to lock voice BEFORE scaling to 200-300. ACCEPTED.
- Chapter 16 (Entity Connectors): define inclusion criteria. ACCEPTED – only sources mentioning Mary Lee by name AND indexable.

From Gemini (strongest operational feedback):

- Jim Ware tri-layer erasure fully developed. ALREADY INTEGRATED in v1.0.
