Abstract

Crimson Hexagon Vendor Ops / Procurement Records (2017 Q1-Q2) — Creative prose in the Crimson Hexagonal Archive. This record is a metadata capture; the complete work is not seated here. A description composed from a reading of the work belongs to the description/wiki review stream. This replaces a batch-restoration stub that described the recovery event rather than the work; recovery provenance is preserved in the record body and in body_status.
